

Membership Plaques

A plaque is given to each member at their ribbon cutting ceremony. Display it in your business to show your commitment to your business and the community. When membership is renewed a new year marker will be received. An e-plaque is available for use on a web site or social media.

This yearly printed publication is distributed throughout the community and included in welcome bags and relocation mailings. Member businesses are listed alphabetically and by category. Advertising is available to Chamber members.





Business Referrals

The Chamber office receives daily inquiries about businesses and service providers in the area. As a member, your business information will be given. The Chamber only refers members.







Web Site

Members are listed on the online directory which includes a link to your business web site in alphabetical order and in two categories. The Chamber web site also contains valuable Chamber and community information and resources. Member enhanced listing advertising opportunity available for directory and banner ads on website.







Presidents Club

Have flexibility to add extra benefits and advertising for a small additional annual fee. This program has a \$400 value for only \$200, and is limited to 12 members on a first come/first serve basis. Program includes three months of a logo and link on Chamber home page, extra visibility in the Weekly Update, Spotlight Business of the month for Newcomer's Board, Pride Night Booth and much more!









Weekly Update

The weekly update is sent to the membership each Friday and is the most effective way to keep members informed on the happenings of the Chamber and its membership. Members are encouraged to submit news and announcements at no cost. Include your business logo for one quarter for \$50! Also for \$50, a PDF flier can be added to the Weekly Update or the PDF flier can be emailed separately.









Labels, Rosters, & Special **Emailing**

For a small fee businesses may obtain a member roster or mailing labels. A special e-mail can also be sent to the membership for a fee.









MyChamber App

MyChamber App is a nationwide mobile directory of Chamber businesses. This application is free and available for download on all smart phones. All Chamber members are listed on the App.





5 Things

A segment of the weekly update published for two consecutive weeks, 5 Things gives each member the opportunity to publish five facts about their business or organization along with their logo. This is a onetime use benefit.







Command Orientation

The Chamber attends every Command Orientation on Fort Leonard Wood. Ambassadors hand out welcome packets to new permanent party military personnel. A business spotlight is chosen each month whose information is on displayed. Members may include marketing items in the packets. The QR code tri-fold will also be handed out with an explanation of what it is and how to use it.









Social Media

Only Chamber members may post announcements to Chamber social media sites.









Member Business Anniversaries

The Chamber recognizes members on their 5th, 10th, 25th, 40th, 50th, 75th, and 100th Anniversary. A photo is requested and put in the weekly update and posted on Facebook.







Shop Local Advertising Campaign

The Chamber partners with our local media members to encourage shopping local in a continued effort to showcase what our local businesses have to offer. One of the ways we do this is by participating with the Shop Small® Business Saturday on the Saturday following Thanksgiving. A portion of membership dues goes towards this program.











Business Showcase

Each month two Chamber members are recognized by the delivery of a business showcase sign to their business in special recognition of their membership. One virtual showcase highlights a Chamber member from the surrounding area. These members will be highlighted in the weekly update, social media, and a press release sent to the area media.
